### DEFINITION OF AN AMATEUR DANCER

**Amateur Status will be deemed lost if a ballroom dancer:**

- Sells or converts into money a prize for dancing.
- Receives expenses from ODS, CDS or other Association for dancing in a competition over and above that for travel, accommodation and meal allowance as duly authorized by the Executive.
- Participates in a dancing competition for which a cash or money voucher prize is offered, unless permission is granted by the Executive and a trust fund set up for this purpose by ODS.
- Accepts remuneration in cash or in-kind for the use of their name or performance as a dancer in an advertisement.
- Declares themselves to be a professional dancer by advertisement or otherwise.
- Takes an entrance examination to any of the professional ballroom dancing bodies or Associations.
- Acts or assists as a teacher of ballroom dancing outside CDS guidelines.
- Acts as an organizer, MC or a floor manager of ballroom dances for personal profit.
- Participates in a competition or team match which is limited to professionals only.

If you do not meet the definition of an amateur dancer as specified above, you must apply for reinstatement and may contact any ODS Executive member to inquire about the procedure.
