Definition of an Amateur Dancer

Amateur Status will be deemed lost if a ballroom dancer:

- a) Sells or converts into money a prize for dancing.
- b) Receives expenses from OADA, CADA or other Association for dancing in a competition over and above that for travel, accommodation and meal allowance as duly authorized by the Executive.
- c) Participates in a dancing competition for which a cash or money voucher prize is offered, unless permission is granted by the Executive and a trust fund set up for this purpose by OADA.
- d) Accepts remuneration in cash or in-kind for the use of their name or performance as a dancer in an advertisement.
- e) Declares themselves to be a professional dancer by advertisement or otherwise.
- Takes an entrance examination to any of the professional ballroom dancing bodies or Associations.
- g) Acts or assists as a teacher of ballroom dancing outside CADA guidelines.
- Acts as an organizer, MC or a floor manager of ballroom dances for personal profit.
- Participates in a competition or team match which is limited to professionals only.


